STEP

1



2014 General Assembly passes Constitutional Amendment to protect marriage. – Done

STEP

2

2015 or 2016 General Assembly must pass an identical Constitutional Amendment to protect marriage. Note: 125 of the 150 legislators who will be voting on the Amendment in 2015 or 2016 will be elected on November 4, 2014!

STEP

3

November 8, 2016 Hoosiers go to the polls to vote on the Constitutional Amendment to protect marriage.
