HATE CRIME LEGISLATION-UNNECESSARY!

SUBJECT: Once again there is an attempt in the General Assembly to pass **hate crime legislation** that would treat **certain categories** of individuals as being worth more than other Hoosiers. This is not right! All individuals should be treated the same! Additionally, courts presently have the authority to enhance a criminal penalty based on certain circumstances. Be watching for more information on this unnecessary and dangerous legislation in the General Assembly!

ACTION: Since language dealing with hate crimes could be added to a bill in the House or Senate, you can contact your State Senator and State Representative with the following message: "Please vote NO on any amendment or any bill dealing with hate crimes because Hoosiers should not be treated differently."

PROTECTING CHRISTIAN SCHOOLS!

SUBJECT: There will no doubt be a number of attempts in the General Assembly this year to add language to a Senate or House bill that would harm the freedom Christian schools now have if they accept a student with a school voucher. One possible amendment would state that a Christian school must hire someone regardless of their religion, their sexual orientation or their gender identity. This would mean that a Christian school would be forced to hire an individual who is a biological male who says he is now a female. This would also force the Christian school to hire someone who is not a Christian.

Additionally, the Christian school would be forced to admit a student who is not a heterosexual or believes they are a different sex. This means that the Christian school could not refuse to admit a biological boy who says he is now a girl. This would also mean that the biological boy would also have access to the girls' restroom and girls' locker room in the Christian school. This effort would not only be harmful to the Christian school, but it would also be harmful to the children at the Christian school.

ACTION: If you support the current freedom for Christian schools including the right to hire teachers and staff that agree with the Bible; and to admit students that agree with Biblical standards for sexuality; then you need to contact your State Senator and State Representative with the following message: "Please vote NO on any amendment or bill that would harm the freedom Christian schools now have if they accept a student with a school voucher, including the right to hire teachers and staff and admit students according to Biblical guidelines."

PROTECTING PARENTAL RIGHTS!

BILL: House Bill 1408

SUBJECT: Parents are presently able to decide when their child will start school. HB 1408 removes this parental authority and would mandate that all children be in school at age 5. Passing HB 1408 would pave the way for the government to force all children into school at 3 or 4 years of age.

ACTION: If you support parents having the authority to decide when their child will start school then you need to contact your State Representative with the following message: "Please vote NO on HB 1408 so parents can still decide when their child will start school!"

SUBJECT: Parents should be able to obtain help for their child if the child is dealing with issues about their sexuality. Unfortunately, not all legislators agree. There could be attempts in the House and Senate yet this year to add language to a bill that would prohibit a counselor from helping a child or teenager from knowing the truth about homosexuality and the benefits of heterosexuality. The harmful language could also prohibit a counselor from helping a child or teenager who is struggling with whether or not they are a boy or girl. This detrimental language is really an attack on Biblical counseling.

ACTION: If you believe that a counselor should be able to help a child or teenager who is struggling with homosexuality; or who is struggling with knowing what sex they really are, then you can contact your State Senator and State Representative with the following message: "Please vote No on any amendment or any bill that would prohibit a child or teenager from receiving help with regard to homosexuality and with regard to understanding what sex they are."

PROTECTING CHURCHES FROM GOVERNMENT CONTROL!

SUBJECT: Churches in Indiana are **currently free** to operate their various ministries **without** government control. Churches are of course required to meet fire codes and sanitation requirements. But the government should **not** be able to tell a church **who** they can hire, **what** they can teach and **how** they operate!

This includes **all** of the ministries of the church including: Vacation Bible School, day camp, Sunday school, Christian school, etc. Unfortunately, some legislators want to **take away** this freedom churches have enjoyed for generations! **Advance America** will continue to **lead** the effort at the State House to protect churches!
